1 for 4 Non-Renounceable Rights Issue - Offer

Dear Shareholder,

1. Rights Issue Details

I refer to my letter to you dated 12 November 2013 in which I advised details of the Company's 1 for 4 non-renounceable pro rata rights issue (**Rights Issue**).

In summary, under the Rights Issue you are entitled to subscribe for one (1) share for every four (4) shares held by you as at the record date (19 November 2013) at an issue price of \$0.08 (8 cents) per share (**Issue Price**). For example, if you hold 1,000 shares as at the record date you will be entitled to subscribe for a maximum of 250 shares at the Issue Price. In the event any fractions of shares occur as a result of the subscription under the Rights Issue your eventual shareholding will be rounded up to the nearest whole number.

You may subscribe for some or all of your entitlement under the Rights Issue. You may also apply for shares in addition to your entitlement although there is no guarantee that you will receive all or some of the extra shares you apply for. Allocation of any shortfall under the Rights Issue is at the discretion of the Company's directors, provided that if any shareholder who takes up shares in addition to their pro rata entitlement would as a result hold greater than 19.9% of the shares in the Company following completion of the Rights Issue then the number of additional shares they would be issued will be scaled back so that they do not hold greater than 19.9%. Additionally, the Company intends to scale back applications on a pro rata basis in the event of excess demand for such additional shares.

The maximum number of shares to be issued under the Rights Issue is 27,287,064. The Company expects to raise up to \$2,182,965.12 under the Rights Issue. As previously advised, the purpose of the Rights Issue is to raise funds to progress exploration and development of the Crater Mountain, PNG Project's High Grade Zone ("HGZ") with the objective of commencing production mid-2014, as well as to cover the costs of the rights issue and for working capital generally.

As also previously advised Freefire Technology Ltd (**Freefire**) and Bloom Star Investment Limited (**Bloom Star**) have agreed to co-underwrite any shortfall under the Rights Issue at the Issue Price on the terms set out in my letter dated 12 November 2013. The Company will however allocate shortfall shares applied for by existing shareholders prior to allocating

any underwriting shares to Freefire and Bloom Star, subject to scale-back as described above.

2. The Company's Situation

The Company's future exploration and development strategy was set out in the Company's 2013 Annual Report which was recently released to the Australian Securities Exchange (ASX) and sent to all Shareholders. In summary, that strategy is as follows:

to develop the Crater Mountain High Grade Zone project ("HGZ") as an area where mining of gold could be undertaken. The Company is advancing an exploration adit with the view of commencing gold production at the HGZ. The cash flow generated from production at the HGZ is planned to finance ongoing Mixing Zone drilling and other exploration activities at the Nevera Project at Crater Mountain.

The Company very recently released the following three very significant announcements to the ASX:

17/10/2013	High Grade Zone - Independent Consultant Target Review
16/10/2013	Porphyry Cu-Au target at Crater identified - Airborne Survey
19/11/2013	Bonanza gold grades intersected at High Grade Zone

Copies of the three announcements are attached for your information. The information in the announcements is briefly summarized as follows:

High Grade Zone - Independent Consultant Target Review

- Report by independent geological consultants, Mining Associates ("MA"), suggests a target for the High Grade Zone prospect based on selective underground mining of:

HGZ Target - 50,000 to 250,000 tonnes at 13 to 30 g/t Au for 60,000 to 100,000 ounces of contained Au

MA cautions that the potential quantity and grade is conceptual in nature, that there has been insufficient exploration to define a Mineral Resource and that it is uncertain if further exploration will result in the determination of a Mineral Resource

- MA confirmed the Company's expectations that the HGZ has the potential to be a rich source of gold which could be developed at low cost and in a short period of time
- MA also state that it is likely that similar independent high grade gold deposits may be repeated at several places as splays off key structures over a potential area of at least 1400m by 700m

Porphyry Cu-Au target at Crater identified - Airborne Survey

- Airborne geophysics combined with drill hole petrology identifies possible location of porphyry copper-gold intrusion inferred from Nevera Prospect drilling at Crater Mountain

- Porphyry copper-gold target interpreted as NE-SW trending intrusion with a possible SW plunge that lies immediately east of and borders the Nevera drilled area
- Aeromagnetic data indicates potential for the copper and gold mineralisation to be preserved closer to surface in the east
- The Mixing Zone inferred gold resource flanks the identified porphyry target on the northwest
- It is expected that the source intrusion for the porphyry mineralisation is also responsible for the Mixing Zone mineralisation
- 7 additional major magnetic targets identified regionally requiring ground follow up, including 1 in southwest Nevera Prospect and 3 in Masi Prospect

Bonanza gold grades intersected at High Grade Zone

- Underground development has intersected bonanza grade gold mineralisation up to **847g/t (27.2 oz/t) Au** over 0.2m of mineralised vein
- Abundant coarse visible free gold
- High grade gold in numerous narrow structures within broad 10 – 15m wide zone
- Drive development is underway to determine the strike extent and overall grade of mineralisation
- HGZ drilling programme to commence in December 2013

3. More Rights Issue Details

The Shares offered under the Rights Issue are in the same class of Shares held by you and the Company will seek their quotation on the ASX.

No disclosure document (prospectus, etc) accompanies the Rights Issue. Investment in equities is at your own risk and the Board recommends that you seek professional advice before deciding whether or not to take up the offer to you.
