Notice under Section 708A(5)(e)(i) Corporations Act

Gold Anomaly Limited ("the Company") previously announced (in April this year) details of the funding facility (up to \$6.7 million) ("the Facility") provided to it by New York based investment fund Spring Tree Special Opportunities Fund, LP ("Spring Tree"). The second advance of funds (\$150,000) under the Facility was made to the Company in May.

In accordance with the terms of the Facility the Company has today issued 8,241,758 fully paid ordinary shares in the Company (as well as 824,176 options) to Spring Tree in repayment of the abovementioned \$150,000 advance.

Accordingly the Company gives notice under section 708A(5)(e)(i) Corporations Act 2001 (Cwth) that:

- 1. the abovementioned securities were issued without disclosure to investors under Part 6D.2 *Corporations Act*;
