The Company has recently entered into a new loan agreement with Freefire for another facility of A\$1.0m of which only \$250K has been drawn down at the end of the quarter. The Company has just launched a Rights Issue which closes 19 February 2019 and is also expected to provide funding for operations. The Company is also expecting gold sales to commence within the March quarter. Should that not eventuate as expected the Company continues to have the support of Freefire if required to meet its obligations.
