1. **Anomaly Resources Limited (ACN 125 210 433) (Anomaly).**
 2. **Persons to whom Gold Aura Limited (ACN 067 519 779) (Gold Aura) made offers dated 14 September 2009 to acquire ordinary shares and director shares in Anomaly.**
 3. **National Stock Exchange of Australia.**

Gold Aura gives notice under Section 650F and Section 630(3) of the Corporations Act and declares that:

- (a) the Offers and each contract formed by the acceptance of the Offers **are free** of the conditions set out in Section 1.9(a) of Annexure A and Section 1.9(a) of Annexure B of Gold Aura Limited's Bidder's Statement dated 14 September 2009 in relation to off-market bids for all the fully paid ordinary shares and all the Director Shares in Anomaly (**Bidder's Statement**);
- (b) pursuant to the notice given by Gold Aura to Anomaly dated 13 October 2009, the Offers and each contract formed by the acceptance of the Offers has already been freed from the condition set out in Section 1.9(a)(vi) of Annexure A and Section 1.9(a)(vi) of Annexure B of the Bidder's Statement;
- (c) pursuant to the notice given by Gold Aura to Anomaly dated 16 October 2009, the Offers and each contract formed by the acceptance of the Offers has already been freed from the condition set out in Section 1.9(a)(ii) of Annexure A and Section 1.9(a)(ii) of Annexure B of the Bidder's Statement; and
- (d) at the time of lodgement of this notice, the voting power of Gold Aura in Anomaly was approximately 98.84%.

Unless the context requires otherwise, defined terms in the Bidder's Statement have the same meaning in this notice.
